Official Rules for the New Jersey Lottery VIP Club Sweepstakes (“Official Rules”):

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Eligibility:

Must be at least 18 years of age on date of entry. Must be a member of the New Jersey Lottery VIP Club at least 72 hours prior to entry into a particular New Jersey Lottery VIP Club Sweepstakes (individually and collectively “VIP Club Sweepstakes”). Individuals can register for the New Jersey Lottery VIP Club for free via the New Jersey Lottery’s website (NJLottery.com). Open only to legal residents of the United States of America and the District of Columbia. Employees and their immediate families living in the same household of the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and their respective parent companies, affiliates, related entities, subsidiaries, and direct vendors, are not eligible to participate in the VIP Club Sweepstakes. To the extent you access the VIP Club Sweepstakes on the New Jersey Lottery mobile application through an Apple device, please be advised that the VIP Club Sweepstakes is not associated with, sponsored, endorsed, or administered by Apple.

Agreement to Official Rules

Participation in the VIP Club Sweepstakes constitutes your full and unconditional agreement to these Official Rules, including the Image Authorization and Waiver and Release of Liability contained in these Official Rules, and you represent and warrant that you meet the eligibility requirements set forth in these Official Rules. In addition, you agree to accept the decisions of the New Jersey Lottery and/or its designee(s) as final and binding in all matters related to the VIP Club Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules. The VIP Club Sweepstakes may be discontinued, modified or withdrawn at any time in the discretion of the New Jersey Lottery and/or its designee(s). As a condition of participating in and/or entering a VIP Club Sweepstakes, you agree that if you are selected as a winner or alternate winner, you shall provide complete, accurate and truthful information to the New Jersey Lottery and/or its designee(s).

Entry Methods:

VIP Club members (sometimes referred to throughout these Official Rules as “entrant” or “you” or “your” or “player”) who have chosen to receive VIP Club Sweepstakes notifications through VIP Club Sweepstakes Emails and/or VIP Club Sweepstakes Text notifications from or on behalf of the New Jersey Lottery will receive such VIP Club Sweepstakes Emails and/or VIP Club Sweepstakes Text notifications when a VIP Club Sweepstakes is available. There is no alternate notification of VIP Club Sweepstakes availability.

In order for VIP Club members to generate an entry into a VIP Club Sweepstakes, the VIP Club member must open the VIP Club Sweepstakes Email or VIP Club Sweepstakes Text and either click the link provided in the particular VIP Club Sweepstakes Email or VIP Club Sweepstakes Text or follow the entry instructions set forth in the VIP Club Sweepstakes Email or VIP Club Sweepstakes Text prior to the announced end of the entry period specified in the particular VIP Club Sweepstakes Email or VIP Club Sweepstakes Text. **Regardless of entry method - VIP Club Sweepstakes Email or VIP Club Sweepstakes Text - each VIP Club member may only submit one (1) entry into each VIP Club Sweepstakes.** The VIP Club member will receive an on-screen confirmation of his or her entry into a particular VIP Club Sweepstakes after receipt of such entry by the New Jersey Lottery and/or its designee(s). There is no alternate method of entry. A player who attempts to enter a particular VIP Club Sweepstakes after the announced end of the VIP Club Sweepstakes entry period will be disqualified from that particular VIP Club Sweepstakes.

Where more than one (1) VIP Club Sweepstakes opportunity is being offered at a time, the New Jersey Lottery VIP Club member must enter each separate VIP Club Sweepstakes within the time periods and in accordance with the instructions specified in each VIP Club Sweepstakes Email or VIP Club Sweepstakes Text, in order to be eligible to win a Prize (as defined herein) for the particular VIP Club Sweepstakes. Each VIP Club Sweepstakes will be scheduled at the discretion of the New Jersey Lottery and/or its designee(s). The New Jersey Lottery and/or its designee(s) reserves the right, in its/their sole discretion, to cancel, terminate, modify, reschedule, or suspend any VIP Club Sweepstakes at any time and without prior notice. Any entry deemed by the New Jersey Lottery or its designee(s) to be: (a) obscene, offensive, or otherwise inappropriate; (b) a violation of any law, regulation, or rule, including these Official Rules and/or the New Jersey Lottery's Social Media Community Guidelines; or (c) unfair, uncooperative, disruptive, fraudulent, potentially fraudulent, or unusual behavior or activity, may be disqualified without notice at the sole discretion of the New Jersey Lottery or its designee(s). All decisions with regard to any VIP Club Sweepstakes, including these Official Rules, made by the New Jersey Lottery and/or its designee(s), shall be final. No purchase necessary to enter or win. A purchase will not increase your chances of winning. The VIP Club Sweepstakes shall be void where prohibited or restricted by law. The VIP Club Sweepstakes are subject to all applicable federal, state, and local laws and regulations.

Image Authorization:

As a condition of entering and/or participating in the VIP Club Sweepstakes, you hereby irrevocably consent to the use of your name, town and State of residence, entry, Prize (if any), photograph(s), video(s), voice, image, and likeness (collectively "Image") by the New Jersey Lottery and its designee(s) in any and all of the New Jersey Lottery's online, printed and social media advertisements, promotions, publications, illustrations, and other Web content throughout the world in perpetuity, including but not limited to, on the World Wide Web, without payment or any other consideration to you. You hereby irrevocably authorize the New Jersey Lottery and its designee(s) to edit, alter, copy, exhibit, publish and/or distribute, without any inspection or approval of use by you, your Image for purposes of publicizing the New Jersey Lottery or for any other lawful purpose. In addition, you hereby irrevocably waive any right to royalties or other compensation arising from or related to the use of your Image. You hereby hold harmless and forever release, discharge and indemnify the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, officers, directors, commissioners, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees, and each of their respective parent companies, affiliated companies, subsidiaries, licensees, and any and all other companies associated with the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC (collectively "Released Parties"), from any and all liability,

injury, damage, death, litigation, claim, cause of action, loss or demand (collectively "Claims"), known or unknown, which you, your heirs, agents, representatives, executors, administrators, or any other persons acting on your behalf or on behalf of your estate have or may have by reason of this Image Authorization, including without limitation, all Claims for invasion of privacy or other legal theory, violation of right of publicity, defamation, libel, slander, false endorsement, and any other Claims regarding personal and/or property rights. The New Jersey Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1.1 et seq.) allows the holders of winning New Jersey Lottery tickets or shares to choose to remain anonymous. This does not apply to the VIP Club Sweepstakes.

Waiver and Release of Liability:

As a condition of entering and/or participating in the VIP Club Sweepstakes, you agree to forever waive, discharge, indemnify and release the Released Parties from any and all Claims that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with your participation in the VIP Club Sweepstakes, your creation and/or submission of an entry, your acceptance, possession, use or misuse of any Prize awarded in connection with the VIP Club Sweepstakes, any defect with the VIP Club Sweepstakes, and/or any error in the administration or operation of the VIP Club Sweepstakes.

Winner Selection and Verification:

Potential Winners and potential alternate winners of each VIP Club Sweepstakes will be selected by a random computerized drawing of all entries submitted and received for the particular VIP Club Sweepstakes in compliance with these Official Rules. The number of winners selected for a particular VIP Club Sweepstakes will be specified in the VIP Club Sweepstakes Email and/or VIP Club Sweepstakes Text sent in connection with the particular VIP Club Sweepstakes. For every one (1) potential winner randomly selected for a VIP Club Sweepstakes, five (5) alternate potential winners will also be randomly selected for that VIP Club Sweepstakes.

Potential Winners will be notified by email sent by or on behalf of the New Jersey Lottery and/or its designee(s), through the email address on file with the VIP Club, with instructions on how to claim their Prize. The instructions may include, among other things, providing such information and documentation as may be required by the New Jersey Lottery and/or its designee(s) within the time required by the New Jersey Lottery and/or its designee(s) ("Claim Information"). If, in connection with any VIP Club Sweepstakes, any winner notification is returned as undeliverable, if a potential winner fails to return the Claim Information within the required time period, if a potential winner cannot or will not accept the Prize, or if the New Jersey Lottery or its designee(s), in its/their sole discretion, deem(s) a potential winner ineligible to receive the Prize for any reason, the Prize will be forfeited in its entirety. In such event, an alternate potential winner will be designated to receive the Prize, based on the order of their selection for the particular VIP Club Sweepstakes, and notified through the email address on file with the VIP Club with instructions on the time and manner in which to claim their Prize. The instructions may include, among other things, providing such Claim Information as may be required by the New Jersey Lottery or its designee(s) within the time required by the New Jersey Lottery or its designee(s). An entrant is not a winner of any prize unless and until the entrant's eligibility and the potential winning entry have been verified and the entrant has been notified that the verification and claim processes are complete.

Prize:

Randomly selected and verified winners of each VIP Club Sweepstakes will receive the Prize specified for the particular VIP Club Sweepstakes in the VIP Club Sweepstakes Email and/or the VIP Club Sweepstakes Text sent for the particular VIP Club Sweepstakes (each a “Prize”). There shall be no substitution of the Prize, no transfer/assignment of the Prize, and cash will NOT be awarded in lieu of the Prize. Each Prize is subject to change at any time and without prior notice in the sole discretion of the New Jersey Lottery or its designee(s). Prizes are awarded “as is” with no warranty or guarantee. Payment of any and all federal, State and/or local taxes associated with a Prize awarded in a VIP Club Sweepstakes shall be the sole obligation of the winner. All winners shall be required to comply with all applicable federal, State and local laws. Any personally identifiable information collected during your participation and/or entry in any VIP Club Sweepstakes will be collected by the New Jersey Lottery and/or its affiliates, designees, related companies, subsidiaries and/or agents and used by the New Jersey Lottery and/or its affiliates, designees, related companies, subsidiaries and/or agents for purposes of the administration and fulfillment of the VIP Club Sweepstakes or as otherwise described in these Official Rules.

The Prize will be sent by the New Jersey Lottery or its designee(s) to each verified winner in full compliance with these Official Rules by UPS to the address on file with the VIP Club. VIP Club members are solely responsible for ensuring that their VIP Club registration information, including home address and telephone number, are correct and up to date. The New Jersey Lottery and Northstar New Jersey Lottery Group, LLC shall not be liable for lost, undelivered or incorrectly addressed packages. The New Jersey Lottery and Northstar New Jersey Lottery Group, LLC shall not have any liability for a player’s failure to receive a VIP Club Sweepstakes Email, VIP Club Sweepstakes Text, and/or a winner or alternate winner selection notification for any reason. As a condition of entering a VIP Club Sweepstakes, you agree that the New Jersey Lottery and its agents, representatives and designees may, and you give permission to the New Jersey Lottery and its agents, representatives, and designees to, publish your full name, town and State of residence, and Prize across the New Jersey Lottery’s social media platforms and Website if you are a verified winner of a VIP Club Sweepstakes.

Changes:

Official Rules may be changed at any time and without prior notice in the sole discretion of the New Jersey Lottery and/or its designee(s).

Disputes:

The VIP Club Sweepstakes is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director’s decision regarding any disputes shall be final.

VIP Club Sweepstakes Integrity:

The New Jersey Lottery and/or its designee(s) reserve(s) the right to cancel, terminate, modify, reschedule or suspend any VIP Club Sweepstakes for any reason, including but not limited to if it/they determine(s), in its/their sole discretion, that a virus, bug, unauthorized human intervention, fraud or other cause (the “Event”) has or is corrupting or affecting the administration, security, fairness or proper conduct of a VIP Club Sweepstakes. In such a case, the New Jersey Lottery and/or its designee(s), in

its/their sole discretion, may select winners from all eligible entries received prior to or after resolution of (if appropriate) the Event. The New Jersey Lottery and/or its designee(s) reserve(s) the right, in its/their sole discretion, to disqualify any individual who tampers with or attempts to tamper with the entry process for any VIP Club Sweepstakes, the operation of a VIP Club Sweepstakes or otherwise violates these Official Rules. The New Jersey Lottery and/or its designee(s) has/have the right, in its/their sole discretion, to maintain the integrity of the VIP Club Sweepstakes and to void an entry for any reason, including but not limited to the use of bots, macros or scripts or other technical means for entering.

Any attempt by an entrant to deliberately damage any system or program of the New Jersey Lottery and/or its agents, representatives, or designees, or to undermine the legitimate operation of any VIP Club Sweepstakes in any way, may be a violation of criminal and civil laws. If such an attempt is made, the New Jersey Lottery and/or its agents, representatives or designees reserve the right to seek compensation from any such person to the fullest extent permitted by law.

Severability; Waiver; Headings:

The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision of these Official Rules. In the event that any provision of these Official Rules is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The headings used in these Official Rules are for convenience only and shall not affect the interpretation of any of the provisions of these Official Rules. The failure to enforce any provision of these Official Rules will not constitute a waiver of that or any other provision of these Official Rules.

Privacy Policy:

Each VIP Club Sweepstakes entry received in compliance with these Official Rules has an equal chance to win a prize. Odds of winning a particular VIP Club Sweepstakes depend on the number of entries received for the particular VIP Club Sweepstakes in compliance with these Official Rules.
